



### Aim

To support younger members of the Endocrine Society of Australia (ESA) to travel to international meetings, laboratories and/or clinics to further their training and knowledge in endocrinology.

### Awards

- One award of \$3,500 will be granted to assist with the costs of international travel to a European destination.  
**Closing date: 1 March 2010.**
- One award of \$3,500 will be granted to assist with the costs of international travel.

- One award of \$3,500 will be granted to assist with the costs of international travel.  
**Closing date: 1 August 2010.**

### Eligibility criteria

- Applicants must have been financial members of ESA for at least 12 (twelve) months prior to the closing date for applications.
- FRACP advanced trainees not enrolled in a higher degree are eligible, but all other applicants must possess a higher degree (MD or PhD), and be within 5 (five) years of award of that degree, or be currently enrolled in a higher degree by research program.
- Applicants must be attending a recognised meeting of a learned society or organisation within the general field of endocrinology.
- All travel is to take place within 9 (nine) months of the closing date for each award. Each applicant can apply only once for each meeting.
- Previous winners are ineligible to reapply for 2 (two) years after receiving their award.

Preference will be given to applicants who meet the following additional criteria:

- 1 who are giving a presentation at the meeting they wish to attend
- 2 who will visit a laboratory(ies) and/or clinic(s) associated with their field of endocrinology
- 3 who are active members of the society as evidenced by attendance and presentation at the Annual Scientific Meeting and other activities.

### Compensation

Compensation will be given for those applicants who have spent periods outside the workforce (due to illness, family leave etc.). In these cases

the criterion of 5 (five) years' full-time equivalence will be applied. The applicant must verify their absence from the workforce in the application.

### Applications

Applications are to be submitted by email to the ESA Secretariat by the deadline. The application should include:

- a covering letter outlining the proposed itinerary and what benefits the applicant intends to obtain from the travel
- a letter of support from their supervisor (who preferably is a member of ESA), details of the meeting they wish to attend (including submitted abstracts), details of the laboratory(ies)/clinic(s) they wish to visit (including letters of invitation where appropriate), and
- a brief CV (highlighting degrees, awards and published works).

Where an applicant is claiming the consideration of an extension of the time from the award of a higher degree (see eligibility criteria), they should provide supporting evidence of their reason for extension.
