



## FROM THE **ESA President**

*“Clinicians: Now is the time to come back to the annual meeting”*

Clinicians and scientists play together more happily in ESA than in many other scientific societies. Having said this, there remain issues to be resolved. For today I will focus on issues related to clinicians and clinician scientists.

Over the years, many practicing clinical endocrinologists have made negative comments about the inadequacy of ESA's meetings for clinicians. If we take the view that this is meant to be constructive criticism rather than bitching and moaning, we need to identify why a number of clinicians have this perception and then address the underlying issues. Many clinicians attend the US Endocrine Society Annual Scientific Meeting and go to the clinically oriented sessions. The meeting is of such a size, that despite the enormous amount of high quality science being presented, one could spend the entire time attending practical clinical presentations. ESA has neither the ability nor the desire to compete with that meeting. On the other hand, any well-informed practicing clinical endocrinologist will know that the approach to clinical medicine in Australia has substantial differences from practice in the United States. Drugs may be used differently, in some cases, drugs available in one country are not available in the other. Funding for drugs, consultations and hospital visits makes approaches to treatment different and medico-legal issues alter approaches to therapy. Thus there is clearly a need for Australian clinical endocrinology meetings.

The clinical weekend and seminar meeting are extremely well attended. Indeed, so well subscribed that we need to turn away late registrants. Thus, I do not believe there needs to be any change to these meetings. On the other hand, clinician attendance at the scientific meeting is less apparent. Many of those who do attend are clinician scientists, interested in the basic and applied science presentations. Endocrine scientists are concerned that any change to the meeting may interfere with the presentation of their high quality science, and this must not occur.

With these constraints, this year ESA is attempting to enhance the clinical component of the meeting without detracting from the scientific component by introducing a specific clinical stream. You may say we have heard all this before. That could be the case as this is not rocket science. However we are making a concerted attempt to make the meeting

**Nominations for ESA Council 2006**

Nominations are now called for election to membership of the Committee of the Endocrine Society of Australia.

The constitutional changes were drafted by ESA Lawyer, David Price, from Paul Duffy Solicitors. These changes were accepted at the Annual General Meeting of the Society that was held on 5th September 2005.

To clarify, the changes are:

1. At the 2006 election the Committee will increase in size from 8 to 10 members (with representation from at least four states or territories of Australia).
2. To make a transition to the new system, at the 2006 election all current committee members will retire. Five members, (those with the most votes) will be elected for a period of 4 years. From these 5, the office bearers will be elected by the committee and the remaining 5 members will be elected for a period of 2 years
3. Beginning in 2008, 5 members of the committee shall be elected every two years.
4. The office bearers will consist of a President, President-Elect, Honorary Treasurer and Honorary Secretary.
5. The President-Elect will be selected by the committee and will have a two year term followed by a 2 year term as President.
6. In 2006 the current President will stay on as Past President for 1 year in an advisory, non voting capacity.

To be nominated, one must be a financial member of the Society, and be nominated by two financial members of ESA. The primary requirement of a committee member is to be prepared to give up some time for the service of the committee.

Nominations for election to the Society must reach the secretary of the ESA, Dr Mark McLean, 145 Macquarie Street, Sydney, NSW 2000 by 5:00 pm, Friday May 12th 2006.

## Call for Abstracts for Annual Scientific Meeting

### Call for abstracts

The abstract deadline is Monday, 1st May, 2006, by electronic mail. As well as the instructions below, the conference website has details for abstract submission, including a checklist that must be completed.

### Presentation Types

Submissions will be accepted for two types of presentation: oral and poster.

Although authors may indicate their preference for type of presentation, the final acceptance with regard to presentation type will be at the discretion of the ESA Program Organising Committee.

Specifically for Clinicians - Some oral and poster sessions will be devoted specifically to clinical endocrinology. Therefore clinical members are invited to submit cases for the Clinical Case Review Session as well as abstracts for the scientific sessions. Clinical Case Reviews can be of great value to the clinician and scientist especially if presented well and more time will be allocated to this session, as it has been so well attended in the past. Please avoid abbreviations for clinical tests, diseases, etc. Above all make sure

that you actually say what has been discovered or learnt from the cases. These reports will also be refereed. Please contact the Chairman, POC, A/Prof. Stephen Twigg for further information.

### Naming your file

Use the following convention "ABSTRACT - ESA03 - Surname of first Author", for example "ABSTRACT - ESA06- Twigg".

### Submitting your abstract

Once the POC receives the Abstract you will receive a Confirmation that it was received. You must also complete the electronic checklist.

### Acceptance of papers for presentation

A subcommittee of the Endocrine Society of Australia will independently review all abstracts. Scientific abstracts should therefore have a brief aim, methods, results, discussion and conclusions. There should be sufficient information for referees to evaluate the material as being sufficiently sound. Accepted abstracts will be published in the Meeting Abstract Book, in the form submitted by the author.

### *A gentle philosophical friend*

Ian went from Sydney High School to the University of Sydney where he graduated in 1946 with honours. His initial resident training was affected and delayed by illness. He had registrar appointments at Sydney Hospital and Royal North Shore Hospital having passed the MRACP exam in 1952. In 1954 he passed the MRCP exam and subsequently went to Boston and worked with Astwood and Raven. In 1957 he returned to RNSH to work with Rundle and Oddie where he made contributions to the rational use of radioiodine in thyroid disease and medical management of thyroid eye disease. He subsequently was appointed as an HMO at RNSH where he continued his clinical activities with emphasis on Endocrinology. During his tenure at RNSH he was involved in teaching both undergraduates as well as post graduate trainees in endocrinology. He retired from the active staff in 1985.

Ian was a foundation member of the Society and was secretary treasurer 1962-64 He was subsequently made an honorary life member of the society and also served on ADRC and CASC.

Ian had a keen interest in sailing art history and philosophy.

He is survived by his wife Joan whom he met when she was an intern in his team at RNSH, two sons and a daughter, and nine grandchildren.

## 2006 SERVIER AWARD

The Servier Award is made annually to recognise the best scientific paper published in the 12 month period preceding the closing date for abstracts for the Annual Scientific Meeting by an active member of the ESA early in their career. The award is given for a single publication, although up to two additional papers may be submitted in support of the application.

### Eligibility:

Society members who are within 8 years of having obtained a higher degree or diploma (i.e. PhD, MD, FRACP) and who are currently financial.

### Regulations:

1. The Servier Young Investigator Award is made by a subcommittee of Council consisting of the President, Treasurer and Honorary Secretary.
2. The award will be presented at the dinner associated with the Annual Scientific Meeting to which the awardee is invited and expected to attend.
3. The value of the award supported by Servier Laboratories Australia is \$1000.
4. The deadline for applications is the same as that for abstracts to the Annual Scientific Meeting.
5. The application must be sponsored by a financial member of the Society who may write a letter in support of the application.
6. Work submitted for publication, but

not yet accepted for publication is not eligible for the award.

7. The work must have been performed predominantly in Australia.
8. The applicant should submit a statement from the department head, or head of research group, signed by all co-authors, which outlines the applicant's role in:
  - a) Planning the design of the work
  - b) Experimental and analytical work
  - c) Writing and revision.
9. The winner may be invited by the Program Organising Committee to present the work at the Annual Scientific Meeting.
10. The subcommittee has a duty to apply the criteria equitable to all applicants.

### Applications:

An original and 4 copies of the application should be sent to the ESA Secretary and must include the relevant publication. Page proofs are acceptable. If the work is 'in press', written documentation of final acceptance must be provided.

Applications are called for travel grants to the ASM 2006. These grants are intended to assist junior members of the society to attend the Annual Scientific Meeting, and generally amount to an Apex Airfare from the applicant's City.

Eligibility:

1. Only members of the society may be awarded travel grants. (Membership must be ratified by Council.)
2. The categories of applicant in order of decreasing priority for consideration are:
  - Full time student (postgraduate) presenting an abstract
  - Research assistant/research officer (NH&MRC scale) presenting abstract
  - Full time student (postgraduate)
  - RA/RO.
3. The supervisor should certify the category and advise whether any other specific support is available from the institution, i.e. travelling scholarship/grant.
4. Generally ineligible for a travel grant are:
  - Members in higher positions than RO
  - Members who are physicians or PhDs more than 7 years post-doctorate
  - Members resident in a country other than Australia.

## Australian Association of Consultant Physicians

March 2006 update.

The Australian Association of Consultant Physicians (The AACCP) – held an annual general meeting in December 2005. A new Council was elected with Dr Leslie E. Bolitho – President, Dr Jack Best – Secretary / Treasurer, Prof Jerry Koutts, Immediate Past President, Assoc Prof Geoffrey Metz, Assoc Prof Gerard Carroll, Dr Louis McGuigan, Dr Andrew Nunn and Dr William Heddle, AMA Liaison.

The new and revitalised AACCP is legally constituted and complies with ASIC requirements. The AACCP has been registered for GST since 1 January 2006.

We have written to all Specialty Society Presidents introducing the AACCP, explaining our role on remuneration proceedings with the AMA, MBCC and Department of Health and Aging. We will also be involved with Workforce issues.

We are seeking support from Specialty Societies and their members. We are encouraging all Fellows to become financial members of the AACCP. We have recently sent letters to all Fellows of the College seeking their financial support and membership of the AACCP (\$99 including GST) for the calendar year from January 1 to December 31, 2006.

There are 540 current financial members of the AACCP. For those who have joined in 2005 their membership has been extended to December 31, 2006. We are in need of more members to support the AACCP and to extend the influence of the physician-base to ensure appropriate representation from Fellows across all Specialties and interests from consultant physicians and paediatricians.

The AACCP Council has met on several occasions in Sydney, and on teleconference. We have established the Secretariat in Sydney. Our registered premises have now moved to Sydney. We have applied to College Council to request seed funding for the Secretariat.

The Technical Reference Group has developed new Enhanced Physician Attendance Item (EPAI) descriptors and explanatory notes. We have met with the AMA, and held teleconferences with the AMA and Access Economics and are currently awaiting the report from Access Economics to be included in our submission.

The submission for EPAIs is well in progress. The new EPAIs numbers have been developed on the advice of the Department of Health and Aging. The Department is interested in new item numbers for current physician work. The existing physician attendance items 110, 116 and 119 will remain.

The AACCP now has an Economist, Dr Robert Wilson, working with the Council. The AACCP is in the process of developing a framework for submission for the new Enhanced Physician Attendance Items to the Department

of Health and Aging. We will be approaching a Canberra based lobbyist to advise on our submission, prior to seeking a meeting with Minister Abbott in the near future. We are aiming to finalize the submission and enter negotiations with the MBCC and DoHA in the next six weeks.

Dr Sue Morey, Chair, RACP Workforce Committee has been seconded to advise the AACCP on Workforce issues.

I would encourage all College Fellows to join the AACCP and become actively involved with issues directly affecting the long term sustainability of Consultant Physician and Paediatrician practice.

**Jock Findlay**

Professor Jock Findlay AM has been awarded the UK Society for Reproduction and Fertility (SRF) Distinguished Scientist Award for 2006.



This award honours Jock's outstanding contribution to reproduction and fertility research. He is the only Australian to have won this prestigious award. He will present a keynote lecture at the Society's Annual conference in July 2006 in Leeds, West Yorkshire, England.

Jock is a world renowned reproductive biologist with more than 30 years of experience in reproductive health research. He was one of the original collaborators on the first paper on hormone replacement in women receiving IVF. His achievements have been recognised through numerous awards including the 2006 Dale Medal the UK Society for Endocrinology. In 2001 he was made a Member of the Order of Australia for services to medical research, as a researcher in reproductive biology and as a medical administrator. He is the Deputy Director of Prince Henry's Institute of Medical Research. He is Chairperson for the Infertility Treatment Authority of Victoria and member of the Scientific Committee and board member of the Victorian Breast Cancer Consortium Inc. ESA congratulates Jock in this prestigious award.

# SIGNIFICANT MEMBER HONOURS

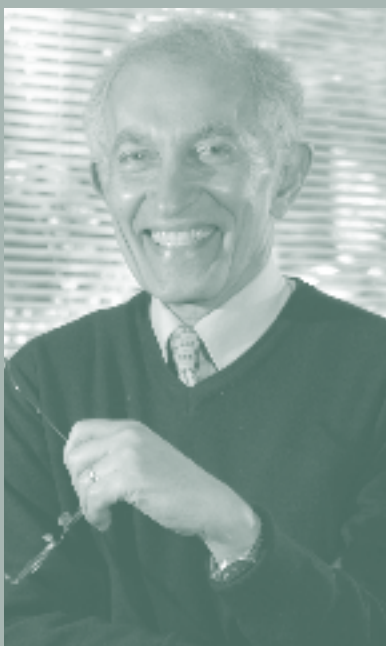
**David de Kretser**

The larger research community and particularly Monash University have paid tribute to Professor David de Kretser AO, who was appointed the next Governor of Victoria on 19 January. He will take over the five-year appointment on 7 April.

David founded the Monash Institute of Reproduction and Development (MIRD) in 1990, which evolved into the Monash Institute of Medical Research (MIMR) last year. He has been at the forefront of reproductive medicine for over 40 years. In 2000, Professor de Kretser was admitted as an Officer of the Order of Australia and in 1996 was elected a fellow of the Australian Academy of Science and the Academy of Technological Sciences and Engineering. In 2001 he was recognised as Victorian Father of the Year.

Monash University Vice-Chancellor Professor Richard Larkins said he was absolutely delighted that a scientist and academic of the calibre and distinction of Professor de Kretser had been appointed to this important role.

"This is recognition not only of David de Kretser's personal qualities, but also of the significance of scientific research to the future of Victoria and the community in general," he said. "David de Kretser will perform the role of Governor with great distinction."



Highlights of Professor de Kretser's scientific and medical career:

- 1985: Discovered inhibin; a hormone that plays a key role in infertility
- 1986: Established the world's first Reproductive Medicine Clinic
- 1990: Founded MIRD
- 1999: Established Andrology Australia; the world's first federally-funded male reproductive health program
- 2000: Admitted to the Office of the Order of Australia
- 2001: Recognised as Victorian Father of the Year
- 2006: Appointed Governor of Victoria
